Subject: **Commencement of Classes for Fall 2025 Semester and Revision of Registration Schedule**

This is for the information of all concerned that the academic schedule for the Fall 2025 semester has been revised.

As per the approved decision of the University Authority, the **commencement of classes for the Fall 2025 semester** has been rescheduled to **January 18, 2026 (Sunday)** instead of the previously notified date of January 04, 2026 (Sunday).

Consequently, the **last date for depositing the student registration fees** has been revised from January 05, 2026 (Monday) to **January 11, 2026 (Sunday)**


Accordingly, the revised schedule of installment-wise payment of fees for the Fall 2025 semester shall be as follows:

- **1st Installment** : Registration Fees by January 11, 2026 (Sunday)
- **2nd Installment** : 30% of Tuition-Fees by March 05, 2026 (Thursday)
- **3rd Installment** : 30% of Tuition-Fees by April 07, 2026 (Tuesday)
- **4th Installment** : 40% of Tuition-Fees by May 10, 2026 (Sunday)

Concerned students are requested to complete their registrations for the Fall 2025 semester after making the payment of 1st installment as per the above-mentioned schedule. **Late fee will not be waived.**

All the Academic Departments are instructed to inform their students of commencement of classes for Fall 2025 semester, revision of registration schedule and installments-wise payments.
